Two [IGM Biosciences](#) business units, Infectious Diseases and Autoimmunity and Inflammation, are now located on the PABC's Doylestown campus. IGM expects that up to 30 scientists and other IGM professionals eventually may be working in our Bucks County facility.



IGM is a clinical-stage biotechnology company focused on creating and developing IgM antibodies. IGM's proprietary IgM technology platform is able to overcome the manufacturing and protein engineering hurdles that have historically limited the therapeutic use of IgM antibodies and allows for the development of IgM antibodies for clinical indications where their inherent properties may provide advantages as compared to IgG antibodies. A collaboration between the PABC and Brandywine Realty, B+Labs at Cira Centre is a new life sciences incubator in University City, Philadelphia, that opened Jan. 3.

The space already is 95% leased to blue-chip life science enterprises, such as Ceptur Therapeutics, Vitara Biomedical and Tmunity. Some already were local but about 45% were from out-of-state. Replicating the PABC model at B+Labs has established a dynamic, flexible community of innovators who can grow their companies as they steward their discoveries into commercial offerings.
